I acknowledge receipt of Al-Merreikh's letter sent today by Dr Mudathir Osman and its annexes, copies which are attached for the other Parties' attention.

According to the Order on Request for a Stay and Conservatory Measures issued on 22 November 2021 by the President of the Appeal Arbitration Division in *CAS 2021/A/8413 Al-Merreikh Sports Club v. Sudanese Football Association*, it appears that Mr Adam Abdullah Makki is the current President of Al-Merreikh and that, therefore, Mr Hazim Mustafa Ibrahim does not seem to have the power to sign any power of attorney in favour of Mr Amir Hizem.
